BGR awarded a \$100,000 grant to Moanoghar for the construction of a dormitory to provide shelter to children of the Chittagong Hill Tracts of Bangladesh affected by conflict or living in remote areas of the country. The grant will sponsor the construction of a three-story building with each floor providing accommodation to 40 children. It will be built from bricks on a solid foundation. When the building is complete, it will accommodate 120 children in total-a permanent solution to the problem of accommodation for the students.

BGR awarded a \$40,000 grant to Helen Keller International to improve access, delivery and utilization of essential nutrition-related services in Kakamega county, Kenya, to identify and promote locally appropriate mother, infant and young child feeding practices, improve the access of nutrition supplements, and strengthen Health Information Systems through improved data collection and analysis of data in order to inform local and national decision-making.

BGR awarded a \$40,000 grant to What If?
