4a (Code:) (Expenses \$ 50,000 including grants of \$ 50,000) (Revenue \$) BGR awarded a \$50,000 grant to Moanoghar for the construction of a dormitory to provide shelter to children of the Chittagong Hill Tracts of Bangladesh affected by conflict or living in remote areas of the country. The grant will sponsor the construction of a three-story building with each floor providing accommodation to 40 children. It will be built from bricks on a solid foundation. When the building is complete, it will accomodate 120 children in total - a permanent solution to the problem of accomodation for the students.

4b (Code:) (Expenses \$ 30,500 including grants of \$ 30,500) (Revenue \$) BGR awarded \$30,500 grant to Bodhicitta Foundation. A portion of the grant sponsors the education & training of 30 teenage girls, providing school fees, clothes, shelter, books & all their other expenses. The girls come from some of the poorest regions in India, are in danger of child marriage or unable to finish high school & university due to poverty, & are being instructed in nursing, social work, & law as well as in job training so they can become agents of change & help others when they return to their villages. A portion of the grant supports a women's social services center benefiting roughly 2,000 people per year that offers legal help to women facing divorce, domestic violence, & land disputes as well as job training to poor women in sewing, computers, English, beauty therapies, & so on. The legal services is offered for free by the previous batch of girls trained as lawyers & social workers. A portion of the grant supports a food program (6,000 meals per year for undernourished slum children), youth groups, counseling, health and human rights workshops, & interventions.

4c (Code:) (Expenses \$ 30,000 including grants of \$ 30,000) (Revenue \$) BGR awarded a \$30,000 grant to What if? Foundation to help provide educational staff and classroom supplies for a recently constructed kindergarten thru eighth grade school in the heart of Tiplas Kazo neighborhood of Port-au-Prince, Haiti which educates approximately 294 students per year.
